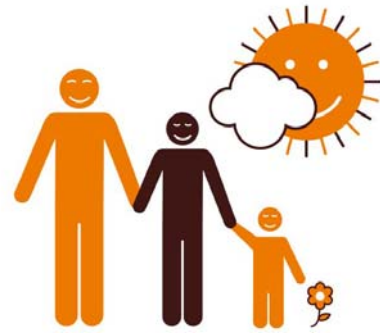

## NRISA 2014 Election Process:

1. On **17 July 2014** the **first email** was sent out, announcing elections and the AGM at 18A Bent St. on 17 August 2014.
2. **Last date** of submitting **nomination** form is **8 August 2014; to the Returning Officer Mr. Arvind Gaindhar, 13 Weigela Ct., Forest Hill, 3131, VIC. to arrive by 5.00 PM on 8 August 2014.**
3. All **nomination** will be **opened** and collated at the above address at **7.00 PM same day**. Any **NRISA member** can come and **inspect** the **nomination forms**.
4. If for **more than the minimum** required **nominations** are received for any positions, **election** will be **held** for those positions (and only for those contested positions) at the AGM, through a **Secret Ballot**.
5. To facilitate maximum participation by the NRISA members **Postal Votes** will be accepted in accordance **with** the **following procedure**, to ensure **authenticity and anonymity** of each vote.
  - a. Names of nominated **candidates will be announced** on NRISA.ORG, on the page <http://www.nrisa.org/17-aug-2014-agm.html>
  - b. A postal voting **form will be uploaded** on this page.
  - c. Anyone sending a **postal vote** should adhere to the following **steps**:
    - i. **Download** the NRISA Postal Voting Form (the form)
    - ii. **Fill** the form as per the instruction on the form
    - iii. **Enclose** the form in a clean unmarked envelope and seal it.
    - iv. **Insert** the clean envelope in another envelope, clearly writing sender's name address, and phone number on its top left.
    - v. **Address** the envelope to **NRISA Returning Officer Mr. Arvind Gaindhar, 13 Weigela Ct., Forest Hill, 3131, VIC.**
    - vi. **Handover, or mail** the envelope to reach Mr. Gaindhar before 5 PM on 15 August 2014.
6. To cast a **Proxy Vote** you will be able to download the proxy vote form from <http://www.nrisa.org/17-aug-2014-agm.html>, if voting is required; or you may use any other form that clearly identifies you and the person appointed as your proxy, and that has been signed by you.
7. NRISA financial members will have **one vote each** at the AGM. Elections will be conducted under the supervision of the returning officer, in the presence of NRISA members.
8. Immediately after the election, votes will be counted in the presence of all NRISA members, tallied and the **winner(s) will be announced on the day**, 17 August 2014.
