I am pleased to advise that the current public liability insurance (PLI) arrangements for your organisation's *Multicultural Senior Citizens Organisational Support 2016-2019* grant has been extended from 4pm 1 March 2018. The Department has secured a new insurance provider, the Victorian Managed Insurance Authority (VMIA).

In order to secure the best coverage for your organisation, the Department has negotiated two separate policies with VMIA. This has resulted in two Certificates of Currency being issued to your organisation, specifically:


